As a result of ISEG Conference, a special issue of Journal of Smart Economic Growth has been published in December 2017 - WELFARE STATE,

SOCIAL POLICIES AND ECONOMIC GROWTH IN SOUTH-EASTERN EUROPE (editor Monica Raileanu-Szeles).

This issue is realized in collaboration with our Jean Monnet Centre of Excellence. The aim of this special issue is to provide a comprehensive overview on the South-Eastern Europe's social map, with a particular focus on the welfare state regimes that have developed here in the last decade and their connection with the economic growth of the region. Over time, the European "generous" welfare state (particularly the Northern welfare state model) proved its inefficiency because of the lack of sustainability, so that this topic has become subject of intense debates all over the Europe. The South-Eastern European countries have combined different characteristics of the traditional models and therefore have developed their own models, which had to continuously adapt to the specific macroeconomic challenges faced by these countries in the transitional process.

We intend to answer questions such as: "What should be the coordinates of the future sustainable European welfare state?", "What welfare state models



are more appropriate to be followed by the South-Eastern European countries?", "Do the macroeconomic peculiarities of the South-Eastern Europe allow the development of traditional welfare state models into this corner of Europe, or rather they require specific models?".

The novelty of the this ISEG special issue consists of analyzing the architecture of the welfare state in a particular region of Europe and its relationship with the economic growth which has not been intensively debated in the literature. This study could give insights into the development of



a new welfare state model in the South-Eastern Europe that emerge from the specific socio-economic characteristics of the region.

Ph.D. student Gabriela Rimbu, winner of a doctoral bursary on 2017, participated in the 21st European Scientific Conference of Doctoral Studies (PEFnet2017), Brno, November 30, 2017.

The Conference was organized by the Faculty of Business and Economics of Mendel University in Brno, Czech Republic.

Gabriela Rimbu presented, in the Session Economics and Finance, the paper "Particularities of youth unemployment and the labor market in Romania as compared with other EU countries from South Eastern Europe".

The paper was then submitted for publication in Journal of Smart Economic Growth, edited by Monica Raileanu-Szeles (member of the research team of our Jean Monnet Centre of Excellence).
